<p>2. What do we process your data for (purpose of processing) and on what legal basis? - Art. 13 (1) lit. c), d) and (2) lit. c) GDPR</p>	
<p>2.1. For employment-related purposes / § 26 BDSG</p>	<p>At PAIR Finance we process your personal data to review your application and qualification. Thus your personal data is processed for employment-related purposes where necessary for hiring decisions or, after hiring, for carrying out the employment contract in accordance with § 26 BDSG.</p>
<p>2.2. For purposes on the basis of legitimate interests / Art. 6 (1) lit. f) GDPR</p>	<p>You have the opportunity to contact us via our website for the purpose of applying for an advertised position. As part of your application process at PAIR Finance we process your personal data you provided for us via our partner Greenhouse Software, Inc.; 18 West 18th Street, 11th Floor; New York, NY 10011 USA (hereinafter "Greenhouse"). The processing via our partner is based on our legitimate interest, Art. 6 (1) lit. f) GDPR. Please find further information in the privacy policy of Greenhouse.</p> <p>Furthermore, if it is necessary, we process your data for the purpose of legitimate interests of us or a third party based on the same legal basis (Art. 6 (1) lit. f) GDPR), e.g. to ensure the accuracy of your information and to monitor and improve the recruitment process.</p>

2.3. On the basis of your consent / Art. 6 (1) lit.a) GDPR	<p>In so far as you have voluntarily provided us with your data beyond the application process (to contact you later with suitable job advertisements), the legality of this processing is given on the basis of your consent (Art. 6 (1) lit. a) GDPR). A given consent can be withdrawn at any time.</p> <p>Please note that the withdrawal will only take effect in the future. 3. 4. How long will your data be stored? – Art. 13 (2) lit. a) GDPR	<p>The storage period is generally a maximum of six months following a decision about your application, unless a contract is concluded or you have given us your consent to the further processing of your data.</p>
5. What data protection rights do you have? – Art. 13 (2) lit. b), d) and Art. 21 (4) GDPR	
5.1. Your data protection rights in general	<p>You have the following rights:</p> <ul style="list-style-type: none"> ➤ right of access to your personal data (Art. 15 GDPR) ➤ right to rectification (Art.16 GDPR) ➤ right to erasure (Art. 17 GDPR) ➤ right to restriction of processing (Art.18 GDPR) ➤ right to data portability (Art. 20 GDPR). ➤ In case you have given your explicit consent, you have the right to withdraw your consent at any time, without affecting the lawfulness of processing before the withdrawal (Art. 7 GDPR).

5.2. 6. Is there a statutory or contractual obligation for you to provide data? – Art. 13 (2) lit. e) GDPR	<p>There is no obligation to provide your personal data to us.</p> <p>Though we only can review your application and your interest in working with PAIR Finance if you provide us with all relevant information. Otherwise we cannot determine your suitability, which is the basis for employment at PAIR Finance.</p>
